Dr. Gowerdhan Ingale welcome all the present members & because of lack of quorum, AGBM was adjourned for hour till 08:45 pm.

Dr. Shailesh Hadgaonkar welcome all the present members and now quorum was not required.

President Dr. Gowerdhan Ingale ask Hon. Secretary Dr. Shailesh Hadgaonkar to start the proceeding of meeting as per agenda.

# 4) Approval of minutes of the last GBM held on 08th June 2024 during POSAC

Minutes of Meeting was circulated on email to all members and same was read by Dr. Shailesh Hadgaonkar.

Dr. Gautam Salunkhe said, in point Constitution amendments if any it's written that No amendments here I need the clarification that there were some objections to the amendments and work is going on because in last 3 or 4 GBM there is no mention about this that somethings are received and some work is going on. Especially in minutes it is mentioned that I need to specify Email no. 1, 2, 3 and no where it is mentioned that work is going on. Somewhere it is also written minutes are the official record which we need for the charity commissioner so it is not just to show the charity commissioner you are showing the charity commissioner that in constitution amendments there are no problem. It is mentions email are received and it is true that work is going on but I think putting in it that work is going on need to be corrected. Second point is the accuracy of minutes that is what I mentioned in the last meeting, here it is written Gautam Salunkhe took objection on writing on the minutes he gave an example of the example of cantonment board, surgical society of medical consultant were they use to write minutes in one month and circulate to the member now this is not entire correct, the example of Pune Cantonment Board I gave which they did not write it for the year, members found out and the published in the paper that this people are not writing for the year and that become a big embarrassment and then they said that was the technical error. So I gave an example of people are not writing and people are writing well in time. But in minutes it is written that everybody is writing in one month which is not correct.

Dr. Yogesh Khandalkar said we will correct that statement.

Dr. Gautam Salunkhe said, on page no. 4 it is written that Dr. Gautam Salunkhe said please be serious about this because it is setting a president so it should be precedent. Again Gautam Salunkhe said things that happened are not in the minutes, it is not everything that should be unanimous and there can be dissonant. What is dissonant? Is this typing error?

Dr. Arjun Viegas said its typing error.

Dr. Dsouza said it should not be so difficult writing accurate minutes through a video recording. If there is a variant in what is been said and what is been written, then I am sorry your minutes need to kept on hold and ratify errors. If charity commissioner finds somethings, then you will be in big trouble.

Dr. Dsouza gave an example of legal cases and told that meeting minutes should be accurate. Further he asked previous president who actually wrote the minutes?

Dr. Arjun Viegas replied, minutes are written by Hafiz

Dr. Dsouza asked whether minutes were scrutinized by committee or by you before signing.

Dr. Arjun Viegas replied not in details we gone through the email.

Dr. Dsouza told that its liability Dr. Arjun, you ratify it to avoid further issues.

Dr. Gautam Salunkhe said when I say write the accurate minutes I am showing this mistakes, in my letter I said the timing of writing of the minutes and their omissions & inaccuracies are staggering, then EC gave reply to me that your accusation is highly derogatory and objectionable. And at another 3 places where I mentioned the words conceal, delay, modify their EC replied, your accusation that the changes were concealed, delayed, modified are false, highly derogatory & objectionable. It is objectionable because I am objecting, it is derogative because it should not happen, it is not false because it is true and I can challenge any EC member how this constitution matter was not delayed, it was not blurred, and parity was not maintained. In the constitution I found on particular day certain para say something and another day its say something else. Everytime I discuss in the GBM and something get change automatically. In the constitution how does this happen? Who does this? And that does not come in your minutes. In the GBM at Poona Club that the constitution problem was their you will not find in the minutes, you will find board of trustees and some explanation, the points which I have raised are not in the minutes as of today. And after that EC gave me a reply what I am saying is false, derogative, objectionable. Can EC show me where this is false.

Dr. Panse replied, what is happened and what you are saying is also correct because I was present in Poona Club. Now you tell me how to proceed further?

Dr. Gautam Salunkhe said, first you don't accuse me

Dr. Panse said, ok accepted.

Dr. Gautam Salunkhe said I appreciate that President, office bearers took the initiative for open discussion, good initiative even I was enthusiastic but what happen later on the whole thing not come in the minutes. So you could not convey to me that you were serious about this. This time also it is written that we should have a meeting etc. which was good. You need to convince me that you are serious about this.

Dr. Gowerdhan Ingale replied, few things Dr. Gautam pointed out in the minutes we will review them and rectify. Second point about the writing the minutes of the meeting, I don't know whether it is mentioned in the constitution about it.

Dr. Gautam Salunkhe said, that is the thing I mentioned in the last meeting that the minutes comes 15 days before the next GBM then how could we remember what happened in that meeting. You need to serious about the writing minutes in time.

Dr. Gowerdhan Ingale said, I don't think it is done by any intention.

Dr. Gautam Salunkhe said, changing of constitution data is done by intension.

Dr. Gowerdhan Ingale said about the writing the minutes we will do it in 3 weeks after the meeting and same will confirm with the EC and then will circulate to the members.

Dr. Ajit Damle said, the minutes can be written in 10 days and the secretary should note the points of discussion during meeting and later with the help of the recording it can be ratify but the wording should be of secretary and not from office person. You may take help of the EC member who is present and interested. So that the question of errors will not remain as 2 persons plus Hafiz will rectify.

Dr. Arjun Viegas said, in recent time this writing of the minutes are given to backoffice but until last 10 years' secretary use to write minutes. I second opinion of Damle sir.

Dr. Yogesh Khandalkar said, nobody is having the intension to change the data in constitution. Every member in the EC is to help the POS members. There is no false commitments in the EC or members so that constitution will be change intentionally. Everyone is working for the society, their might be error, typing mistakes which can be ratified and senior persons like you should guide us to ratify rectify such mistakes but there is no such intension to change data in constitution amendments.

Dr. Gautam Salunkhe said, I can prove that constitution on particular day says something and on another day says something.

Dr. Gowerdhan Ingale said, about the changes in amendment suggested by Dr. Gautam Salunkhe, I would like to inform GB that according to the discussion and decision in last GBM, Dr. Gautam Salunkhe email his letter to office on 07<sup>th</sup> July 2024 and on same day it was discussed in 1<sup>st</sup> EC meeting for around 2 hrs and later it was discussed in 2 meetings one with EC and one with Past President & Secretary of last 3 years. And according to all this meeting we forwarded an email to all POS members. We also asked the reply from Dr. Gautam Salunkhe on the same. Now the 8 points raised by him about amendments out of 5 are graciously accepted. And

again we take and meeting with Dr. Gautam Salunkhe in last week for remaining 3 points fortunately all are resolved and now we will forward these amendments to Legal Committee to frame this in legal manner in constitution. And after Legal Committee report we will keep it in the EC meeting and then same can be kept for approval in extra ordinary GBM or next GBM.

Dr. Shailesh Hadgaonkar said, Dr. Yogesh Khandlkar was saying, all the members are trying to help the POS from their side there is nothing animosity or going against any person for sure. We are here for last 3 months and for rectifying the things going on for last 3 years we have taken efforts to understand everyone and mutually come up with the best possible things which we can give it to our POS. If we are not coming to the consensus, then this will continue to couple of years and this will never be solved. Most of the time there may be technical error or clerical error I understand, I am on body of ASSI tis things are happening everywhere it's not that it's with POS only and no one is doing it intentionally. And its practically not possible for Secretary to write all the things whatever somebody is talking, in last 15 years I have not seen it we have the video recording we should listen to it, rectify and correct the mistakes. At the same time, we all should come up conclusively and corrosively to come up to the answers to the problems which is we are facing otherwise this will continue for next few years as we are seeing it for last 3 years.

Dr. Gautam replied, ok I agree with you what you said. Unfortunately, your official reply to me regarding that Power to remove difficulty point It is typing error and same is corrected, can you show me where it is corrected whereas other things was twisted this way that way till now. In power to remove difficulty for day to day running of society this is first para and where in second para give the right to amend the constitution straight with the EC without going to the GB and raise this in POS in 2022 and in MOA 2022 and nobody wanted to take it because it is good thing for you. Using that clause in MOA EC change the thing and that is the danger. Recently we had a MOA Legal Committee meet and in that one of the Honourable member found this para wrong and the whole para was removed. This I was telling since 2021 in MOA.

Dr. Gowerdhan Ingale said, sir we had this discussion in last meeting with you and the word EC is corrected to GB. Second about the Power to remove difficulties it is decided in the last meeting that Legal Committee will frame that and give to us in.

Dr. Dsouza said, does our legal committee has any qualified lawyer? I offer if EC agrees I can approach EX. Charity Commissioner Pune to guide us.

You can decide in EC and let me know. I feel somebody with legal qualification should be in committee which will give weightage to it.

Dr. Gowerdhan Ingale said, in previous some EC meeting it was decided that instead of taking outside member we all should seat and decide amicably but if it is helpful we can discuss in EC and get back to you. Further he appeals all present members to come forward in Legal Committee which will be helpful to come with better solutions.

Dr. Panse said, what I gather from all discussion that, Dr. Gautam Salunkhe is in the best interest of POS, so what you said in continuation with that can you opt him in committee for this purpose. Because what he is talking about the wording, language, presentation everything, he is not objecting about your working, whatever on paper he is objectinh that so he will be helpful to formulate whatever has happen, So can you request him to come in committee.

Dr. Arjun Viegas requested Dr. Salunkhe to come in Legal Committee.

Dr. Gautam Salunkhe replied Thanks & I will be happy to join if it is helpful. Dr. Yogesh Khandalkar said I also have an interest to join legal committee and same is agreed.

Dr. Gowerdhan Ingale said we require more members to come in Legal Committee I purpose name Dr. Karne, Dr. Gautam Salunkhe, Dr. Yogesh Khandalkar, Dr. Swapnil Bhise, Dr. Sham Shinde for the Legal Committee members. Seconded by Dr. Sachin Nagapurkar and approved unanimously.

Dr. Gowerdhan Ingale appreciated the efforts taken by all past & present office bearers for getting resolution these amendments.

# 5) Approval of POS Audited accounts of financial year 2023-24

Dr. Yogesh Khandalkar presented the audited accounts report for financial year 2023-24. He told that this year we have surplus amount of Rs. 4,67,000 to POS account.
