4) To confirm the Minutes of last AGBM conducted on Saturday, 19th October 2024 at Hotel President, Pune

Minutes of Meeting was put on website for all members and same was displayed on screen by Dr. Sachin Abane, Minutes were proposed by Dr. Talesara for approval, seconded by Dr. Yogesh Khandalkar and It is approved unanimously.

5) To confirm the Minutes of last EGBM conducted on Monday, 31st March 2025 at Hotel President, Pune

Dr. Gautam Salunkhe asked are the minutes accurate?

Dr. Sachin Abane replied, yes, we try to mention all

Dr. N J Karne replied, purpose of confirming minutes is whatever discussed in the meeting is written in minutes and any member find disparity he can bring to the notice and can be corrected. Instead of asking question, if you find any lacunae tell them.

Dr. Gautam Salunkhe said, from 2022 we were discussing the points Powers of EC and were reasonably settled. But again, here the postponement of GBM is approved in EC and the same things happens. EC can take decisions which are not mentioned in constitution in good faith.

Dr. A N Damle said, which lines, words need to be corrected you tell them or write to them that can be corrected.

Dr. Sham Shinde said, if its an object on what is mentioned in constitution then it should have taken in previous GB.

Dr. Gowerdhan Ingale said, let me clear the points raised by Dr. Gautam Salunkhe were discussed in EGBM dated 31/03/2025 and resolved amicably, now he has some objection on the words mentioned in the minutes of 31/03/2025 EGBM which can be corrected as per the video recording.

Dr. Shailesh Hadgaonkar said, it is impossible to write the minutes of more than one hour word by word so there are chances of missing words and for the same this confirmation of minutes comes to the agenda.

Dr. Gautam Salunkhe said, in last EGBM the chairman of board of trustees gave an statement in future Hadapsar can be separated which was shocking to me.

Dr. N J Karne replied, there is confusion on this, there is nothing like separation, PCOA is not separated from POS. POS is the parent body, as I said there are many local problems. PCOA is affiliated by MOA also but as a regional body, for MOA POS will be always district chapter and not PCOA. There are some local problems for e.g. at Indapur where the local club can form and the issues can be resolved. Its doesn't mean the separation. POS is the parent body under which the other subspeciality, local clubs can come.

Dr. Sachin Abane said, whatever Karne sir said in that meeting is his opinion or views, that may not be in the minutes, in minutes the important discussions of meeting are mentioned. Whatever points were resolved in the EGBM is with help of Dr. Salunkhe, Dr. Sham Shinde and we are thankful to you. But if you want to change any sentence in the minutes as per the discussion then it can be done but new point can't be taken.

Dr. Gautam Salunkhe said, whatever we discuss and resolved in EGBM was nothing to do with the statement of Karne sir.

Dr. Sachin Abane said, now Karne sir explained us his intentions behind the statement.

Dr. Sampat Dumbre Patil asked Dr. Gautam Salunkhe the four points discussed in EGBM are correct.

Dr. Gautam Salunkhe said, yes.

Dr. Sampat Dumbre Patil said, thank you and we are very much thankful to you as you have studied it very well.

Dr. Sachin Abane said, in future for any legal issues we request Dr. Gautam Salunkhe to be the part of committee.

Dr. Sachin Abane asked Dr. Gautam Salunkhe to email the sentence he wants to be corrected, the same we will put it in EC and after approval it can be corrected.

Dr. Kiran Kharat said, what I can understand that if all the points are amicably resolved and if between new points come up then read it discuss it, I don't know the law but this should not happen. There are lots of thing to discuss in GBM and we all are stuck here for years.

Dr. Gowerdhan Ingale replied, what is Dr. Salunkhe is asking to correct is in minutes and not in constitution or resolution.

Dr. Shailesh Hadgaonkar said, two hours recording to write is difficult.

Dr. Abhijeet Mahadar proposed rest of the minutes for approval excluding the sentence Dr. Salunkhe had an objection. Seconded by Dr. Hemant Patil. It is approved unanimously.

6) Report of Secretary, POS from June 2024 – Dr. Shailesh Hadgaonkar

Dr. Shailesh Hadgaonkar gave the secretary report – 18 new applications for POS Life memberships and 1 Honorary membership were received to POS office from June 2024 to March 2025.
