Eligibility Criteria for individual Posts

1) President Elect:

- He should be life member of the association for at least 10 consecutive years.
- He should have served as Secretary of the Society for at least 1 full term.
- He should not be convicted for criminal charges before any Competent Court, Authority and or Medical Council of India and State Medical Council. If there is medical profession related reason for criminal charges, he can take prior permission and approval from Executive Committee to contest the Election. It is the Executive Committee, who will decide and define whether the charges are of criminal nature or not.

2) Secretary and Treasurer:

- He should have completed 2 years as Elected EC member of POS at the time of applying for the post, and or at the time of assuming the office.
- He should not be convicted for criminal charges before any Competent Court, Authority and or National Medical Council and State Medical Council. If there is medical profession related reason for criminal charges, he can take prior permission and approval from Executive Committee to contest the Election.

3) Executive Committee Member

- He should be life member of the association for at least 5 consecutive years.
- He should not be convicted for criminal charges before any Competent Court, Authority and or National Medical Council and State Medical Council. If there is medical profession related reason for criminal charges, he can take prior permission and approval from Executive Committee to contest the Election.

If an elected person resigns from his post without any justifiable cause, explained to Executive Committee and if the reason is not accepted by Executive Committee, he will not be eligible to contest any post for next 5 years, from such resignation.
